## <u>TYPE OF DEPLOYMENT:</u> DREW TASER, ACTIVATED, AIMED

**Summary of Incident**: On 7/2/2022, deputies were dispatched to a report of a grand theft and a the theft of a vehicle. The victim reported her ex-boyfriend entered her apartment and stole miscellaneous electronics, her car keys and then left in her vehicle. The suspect was also the restrained person in a served domestic violence restraining order which listed the victim as the protected. The victim confronted the suspect while he was inside her residence and the suspect became aggressive, grabbed the back of her head and threw her on the bed. The suspect also forcefully removed the victim's cell phone from her hand during the incident. Deputies later located the vehicle and the suspect walking nearby. Deputies told the suspect to stop walking, but the suspect ignored their commands. Because the suspect was reported to have committed violent felonies, the suspect had a large stature, the suspect had a history of resisting arrest, the deputy drew his CEW, turned it on, and pointed it at the suspect. The deputy gave the suspect commands and set down a small bag and knife down. The suspect was then transported to the Marin County Jail and booked into custody and arrested for the above listed charges. The CEW was not fired during this incident.

The victim was away from home and saw a subject wearing a neon safety vest manipulating the lock of the front door of his residence from his home security cameras. Deputies responded to the area and located the suspect running from the open garage of the victim's house. Upon seeing the deputy, the suspect fled in a van with cable company markings on the side. The deputy pursued the suspect and observed him make multiple vehicle code violations as he fled into out of the county ignoring the deputy's emergency lights and sirens. While fleeing the suspect veered off the roadway causing the vehicle to become stuck in the heavy brush. The suspect exited the vehicle and fled on foot. The deputy ran after the suspect who ignored his commands to stop as they ran. The deputy was able to close the distance and ordered the suspect to the ground. The suspect complied and was placed into handcuffs and arrested for the above charges. The vehicle the suspect was driving was later determined to be stolen. The CEW was not fired during this incident.

**Summary of Incident**: On 7/25/2022, deputies were dispatched to a subject reported to be stabbing himself with a knife. Deputies arrived on scene and saw a blood trail near the entrance to the residence. The deputies found the subject arguing with family members and could see he was bleeding from an undetermined location. The deputies attempted to detain the subject to be taken for medical and psychiatric care but the subject began struggling while on the floor in an attempt get away. One deputy drew his CEW, turned it on and pointed it at the subject. The deputy told the subject if he continued to fight, he would be tased. The subject became compliant and stopped struggling. Additional deputies were able to place the subject into handcuffs to be taken to the hospital. The CEW was not fired during this incident.

#### **Summary of Incident:**

On 7/31/2022, deputies responded to a gas station for a report of a subject who stole cigarettes and left the area on a bicycle. Deputies located a subject in the area matching the description provided by the employees. The deputy activated the lights and the siren of his patrol vehicle to signal to the subject to stop. The subject attempted to flee on his bicycle while ignoring the deputy's commands. Eventually, the subject fell and a physical altercation ensued between the deputy and the subject. During the physical altercation, the subject attempted to bite the deputy and picked up a wooden stick. The deputy drew his CEW, turned it on a pointed it at the subject. With the display of the CEW, the subject complied and was taken into custody. The CEW was not fired during this incident.

#### **Summary of Incident:**

On 8/9/2022, deputies were dispatched to a park to search for a subject who left the custody of an emergency psychiatric facility. The subject was no longer on a psychiatric hold but was considered to be chronically disabled. Deputies search the area but were unsuccessful. Approximately forty minutes later, deputies were searching the same the area for a subject who was wanted for 245 PC, Assault with a Deadly Weapon after stabbing another subject. Deputies received information from a citizen there was a subject with a similar description in a bush nearby. Deputies located the subject under a bush. Believing the subject in the bush was the subject who recently stabbed another person, one deputy drew his CEW, turned it on and pointed it at the subject. The deputy gave the subjects commands to the subject to exit the bush to which the subject complied. The subject was placed in handcuffs and determined to be the subject from the hospital and not associated with the assault. The subject was returned to the custody of the psychiatric facility. The CEW was not fired during this incident.

#### **Summary of Incident:**

On 9/1/2022, detectives with the Marin County Sheriff's Department and Marin County Probation attempted to locate and arrest wanted, armed robbery and carjacking suspects at a hotel. The detectives surrounded the hotel room and made announcements identifying themselves as law enforcement to the subjects inside the hotel room and told them to make their hands visible. The subjects attempted to slam the door shut and barricaded themselves inside. Due to the suspect committing violent felonies involving firearms, detectives had their department issued firearms drawn. One Sergeant on scene had his CEW drawn, activated and pointed it at the subjects. The subjects inside the room ultimately complied with commands and were taken into custody. The CEW was not fired during this incident.

**Summary of Incident:** On 9/4/2022, deputies were dispatched to a male who was hitting a shared wall and yelling at his neighbor through the wall for approximately twelve hours. At one point, the reporting party believed the subject was hitting the wall with something, possibly a metal pipe, which put a hole through the wall. The victim requested to place the subject under arrest for the vandalism. The subject also had an outstanding warrant for his arrest and previously fought with deputies on a prior incident. Approximately two hours later, the property management responded to the residence to repair the damage. The subject refused to exit his residence despite the deputies' request. Deputies ultimately had to force entry into the apartment. Due to the subject's history of resisting deputies, his refusal to comply with commands, his outstanding warrant, and because he was possibly armed with a metal pipe, one deputy drew his department issued CEW, activated it and pointed it at the subject while giving the subject commands to put his hands up. With the display of the CEW, the subject complied and was taken into custody. The CEW was not fired during this incident.

### **Summary of Incident:**

On 9/17/2022, Deputies were dispatched for a physical alternation at a wedding reception. One employee of the venue reported a female threw a glass bottle at him. Upon arrival, the two deputies on scene found a large number of intoxicated persons in a physical altercation with the potential to become violent. One deputy unholstered her department issued Taser 7 Conducted Energy Weapon, turned it on, and pointed it at the agitated subjects in the melee. She kept her CEW pointed at the agitated subjects and ordered parties to separate in an attempt to prevent injuries or harm to herself or any other persons on scene. Other party patrons began to assist in separating the subjects involved in a physical altercation as additional deputies arrived to assist. Deputies were able to remove the victim from the situation and disperse the physical altercation without the CEW being fired.
