Summary of Incident: On 1/11/2023, deputies responded to a report of a subject inside a vacant residence, "Going hod wild glass breaking." Upon arrival, deputies heard breaking glass and saw an orange glow with smoke coming from inside the residence. Due to not being able to confirm how many individuals were in the residence along with the violent nature of the call, deputies had their department issued firearms drawn at the low ready position and announced their presence. One deputy noticed one male in the living room and pointed his firearm at the male while instructing him to lie on his stomach with his hands out, to which he did. The second deputy noticed the same male who was wearing only jeans and socks. The suspect didn't appear to have any weapons on his person, to which the second deputy transitioned to his department issued CEW. He activated my Taser and pointed it directly on the subject. The subject complied with the deputies' commands while making nonsensical statements about a deer and burning the house. The deputies placed the subject under arrest for the above listed charges and extinguished a fire inside the residence. The Taser was not fired during this incident.

Offense(s): 148 PC Resisting Arrest, 11350 H&S Possession of Narcotics, 647(f) PC Public Intoxication, 11364 H&S Possession of Drug Paraphernalia in addition to San Mateo County warrants for theft.

Summary of Incident: On 2/22/2023, deputies were dispatched to a retail store for a report of two female subjects stealing items. Deputies arrived on scene and located the suspects who were in a verbal argument near a open vehicle. As deputies approached the vehicle, one suspect exited the vehicle, walked toward the back of the car and reached inside. The deputy drew his department issued CEW and pointed it at the subject while giving her commands to not reach into the car. The suspect removed various articles of clothing with price tags on them from the car and threw them onto a nearby vehicle. The suspects ignored the deputy's commands and continued to engage in a verbal argument until one suspect walked away. At this time the other suspect complied with the deputy's commands and was placed in handcuffs.

An additional deputy walked with the second suspect, ultimately de-escalating the situation by calming her down. During the conversation, she found she was wanted for two outstanding San Mateo County warrants. She also admitted to taking items from the store without paying.

After further investigation, one suspect was arrested for two felony out of county warrants,148 PC, 11364 H&S, and 11350 H&S and the other suspect was arrested for 647(f) PC and 11364 H&S. The CEW was not fired during this incident.

PC (Stalking), and 243(e)(1) PC (Misdemeanor Domestic Battery)

Summary of Incident: On 3/19/2023, deputies were requested to assist San Rafael Police Department in searching for a subject who was wanted for 594(b)(1) PC (Felony Vandalism), 459 PC (Burglary), 422 PC (Criminal Threats), 646.9 PC (Stalking), and 243(e)(1) PC (Misdemeanor Domestic Battery) after he "broke into" victim's apartment and "threatened to kill the victim with a gun." Deputies were positioned on a perimeter when they were advised by other officers a subject matching the suspect's description was running towards them. One deputy observed the subject running and followed the subject until she was able to position her patrol vehicle ahead of the suspect. She exited her patrol vehicle and pursued the suspect on foot before he yielded. Because the suspect was reported to have used a firearm in the crime he was wanted for the deputy drew her department issued firearm and held it at a low ready

position. She gave the suspect commands to get on the ground to which the suspect challenged the commands. As additional officers arrived, the deputy transitioned to her department issued CEW to provided a less lethal force option. She drew her CEW, activated it and pointed it at the suspect. An additional deputy on scene drew his CEW, activated it and pointed it at the suspect as well. With the display of multiple force options and continued commands, the suspect ultimately complied with commands and was taken into custody for the above listed charges. The CEWs were not fired during this incident.
