As the deputies were attempting to place the subject into custody, the suspect attempted to leave. The deputy drew his CEW from its holster, activated it and pointed the CEW at the suspect. Upon seeing the CEW and hearing the verbal commands from the deputy, the subject complied, sat on the ground and was taken into custody. The suspect was ultimately taken to the hospital for a mental health evaluation.

Summary of Incident:

On 1/13/2020, deputies were dispatched to man waving a firearm and yelling near the roadway. Deputies arrived and located the subject matching the description. One deputy pointed his firearm at the subject and a second deputy drew his CEW, activated it and pointed it at the subject. With the display of the weapons, the subject followed the deputies' commands and was detained for further investigation. Ultimately, the deputies determined the subject was waving a black cell phone and yelling.

On 1/22/2020, deputies conducted a traffic stop and determined the driver was in violation of driving under the influence. When the deputy advised the subject he was under arrest, the subject became uncooperative and actively resisted deputies. A deputy drew his CEW from his holster, activated it and pointed it at the suspect. With the display of the CEW and the commands from the deputies, the subject complied and was taken into custody.

Summary of Incident:

On 1/25/2020, deputies responded to a structure fire. While responding to the fire, a sergeant saw a subject running away from the fire who was not wearing shoes or a shirt, was in a frantic state, and appeared to be under the influence of a controlled substance. Believing the suspect was under the influence and a suspect of arson, deputies attempted take the subject into custody. The subject took a fighting stance challenging the sergeant. After giving the subject commands, the sergeant drew his CEW from its holster, activated the CEW, pointed it at the subject's back and gave the subject more commands as another deputy attempted to place handcuffs on the subject. While trying to handcuff the suspect, the suspect began physically resisting and struck a deputy in the head and kicked a sergeant in the leg. The sergeant fired one cartridge towards the subject. The CEW probes struck the subject in left side of his upper body. The CEW did not incapacitate the subject and the subject continued to physically resist. Two more deputies arrived and the subject was taken into custody.

On 2/29/2020, Deputies with the assistance of Sausalito Police Department located a suspect wanted on a Felony Marin County Warrant for Possession of a Stolen Vehicle. The suspect attempted to hide in the cabin of a boat and refused to exit the boat. Deputies boarded the boat and prior to contacting the suspect, a deputy removed his department issued Conducted Electronic Weapon (CEW) from his holster, turned the CEW on and pointed the aiming laser at the suspect. With the display of the CEW the suspect complied with the deputies' commands and was taken into custody for the outstanding warrant and the additional charge resisting/obstructing arrest.
