Summary of Incident: On 10/14/2020, deputies responded to a report of gun shots heard in a residential area. While checking the area, deputies saw a vehicle fail to stop at a stop sign and drive on the wrong side of the road. Deputies attempted to conduct a traffic stop on the vehicle but the driver fled driving recklessly through the neighborhood. The driver then fled from the vehicle on foot. As deputies pursued the subject, he threw a backpack into the backyard of a family residence. Deputies were able catch the subject and the subject began fighting and actively resisting the deputies' attempts to take him into custody. A deputy drew his department issued CEW, activated it and pointed it at the subject. With the display of the CEW and commands by the deputy, the subject complied and was taken into custody. Deputies later located a loaded firearm with a large capacity magazine in the backpack. The subject was ultimately arrested for Vehicle Code violations, Weapons Violations, Child Endangerment and Resisting Arrest charges.

Summary of Incident: On 10/31/2020, a deputy stopped to assist a vehicle pulled onto the shoulder of Highway 101, partially blocking traffic. The deputy found a male and female standing outside of the vehicle and another subject seated inside the vehicle. The female requested assistance from the deputy because the male seated inside the vehicle was intoxicated and needed to be escorted home. As the deputy made contact with the subject seated inside the vehicle, the subject began cursing and threatening the deputy and refused to follow the deputy's instructions to stay seated in the vehicle. The deputy determined the subject was under the influence and unable to care for himself and needed to be placed under arrested for being drunk in public. Because the subject was uncooperative and not following directions, the deputy drew his department issued CEW, activated it and pointed it at the subject until additional deputies arrived. With the display of the CEW, the subject followed the deputy's commands and was taken into custody when additional deputies arrived.

Summary of Incident:

On 11/27/2020, a victim reported she got into an argument with her boyfriend. During the argument, her boyfriend grabbed her by the throat and pushed her against the wall. During the argument, the victim was also assaulted by her boyfriend's cousin. Later, the victim's family confronted the suspects and the suspects threatened the family members with a firearm. Deputies went to the suspects' residence to attempt to place them under arrest for the above crimes. Due to the reported firearm involved in the crimes and the violent nature of the crime, one of the deputies on scene drew his department issue CEW, activated it and pointed it at the suspects as they were taken into custody. At the display of the CEW and the deputies' firearms, the subjects complied with commands and were taken into custody.

When deputies advised the subject he was under arrest, the subject took a bladed stance, clenched his fists and pulled away from the deputies when they tried to detain him in handcuffs. The subject yelled, "I'm not going to jail!" Because the subject was actively resisting and refusing to be taken into custody, a deputy drew his department issued CEW, activated it and pointed it at the subject. The subject continued to ignore deputies' commands with the display of the CEW and was taken into custody after the Oleoresin Capsicum (OC) spray was used.

The deputy advised the subject to be seated as he waited for an additional deputy in order to conduct a probation search. At this instruction, the subject became angry, began yelling, threw a bicycle wheel, began to walk away and stated he would not cooperate despite the terms of his probation. The deputy drew his CEW, activated it and pointed it at the subject while giving the subject commands to sit down. With the display of the CEW, the subject complied with commands until additional deputies arrived and could assist placing the subject into handcuffs.

Summary of Incident:

On 12/4/2020, deputies were dispatched to a vehicle collision on Highway 101. When the deputies arrived, they found the vehicle had collided with a semi-truck and the vehicle partially blocking traffic. As the deputies contacted the driver, he attempted to put the vehicle in drive and flee the scene. The driver appeared to be under the influence, was refusing to get out of the vehicle and tried to drive away multiple times. Deputies attempted to physically remove the subject from the vehicle but the subject resisted, continuing to try and drive away and clenching onto the steering wheel to prevent deputies from removing him. Deputies discharged the CEW four times. The subject was not incapacitated by the CEW. Ultimately, additional deputies and officers arrived and they were able to remove the subject from the vehicle and take him into custody. The subject was arrested for driving under the influence, attempting to flee the scene of a vehicle collision and resisting arrest related charges.

Summary of Incident:

On 12/12/2020, deputies within the Marin County Jail were releasing a subject who had been booked by an outside agency for drug related charges. While attempting to complete the booking release process, the subject became aggressive with deputies and refused to follow commands. Deputies attempted to place him into a holding cell to safely detain him until he became cooperative. While doing this, the subject charged the holding cell door and positioned himself in the doorframe so the deputies could not shut the door without causing injury to the subject. While in the door frame, the subject broke a nearby sign and armed himself with sharp shards of plastic. The subject held the shard of plastic to his own neck indicating the intent to harm himself. Based on his erratic behavior and aggressive actions, deputies determined the subject may be experiencing a mental crisis and was a potential danger to himself or to others. The deputies determined he needed to be taken to the hospital for a mental health evaluation. After several deputies attempted to negotiate with the subject and de-escalate the situation, a Sergeant activated a CEW, pointed it at the subject and eventually discharged the CEW. The CEW caused the subject to fall to the ground, allowing the deputies the opportunity to retrieve the shards of plastic and safely place the subject into handcuffs. The subject was then transported to the hospital in a restraint device and taken for a mental health evaluation pursuant to 5150 W&I.

Summary of Incident:

On 12/19/2020, Deputies responded to a report of a subject acting suspiciously in a business area and was reported to be under the influence of alcohol. Deputies contacted the subject and interviewed him as to why he was in the business park. During the contact the subject was displaying signs of being under the influence of a controlled substance. As deputies attempted to detain the subject to conduct a search, the subject fled on foot. A deputy caught up to the subject a short distance away. The deputy drew his CEW, activated it and pointed it at the subject while giving him commands. With the display of the CEW, the subject complied with the commands and was taken into custody. The deputies then determined the subject was also wanted for an outstanding felony Parole Violation warrant.

Summary of Incident:

On 12/23/2020 at approximately 0400 hours, a deputy was on patrol when he observed a vehicle elevated on a jack and subjects who appeared to be in the process of stealing a catalytic converter. When the deputy attempted to contact the subjects, they fled in a vehicle. One of the subjects was later located in the neighborhood with the vehicle. The suspect vehicle was also determined to be stolen out of Oakland. The second two subjects were located after a citizen reported seeing two subjects run through his backyard. Deputies located the subjects hiding in the citizen's backyard. The two deputies each drew their CEWs, activated them and each pointed them at one of the subjects. Due to the elevated hiding position of the suspects, the deputies determined they would be unable to utilize the

CEWs and holstered them. The suspects ultimately complied with commands and were taken into custody. The suspects were arrested for possession of a stolen vehicle, vehicle tampering, possession of burglary tools, possession of a controlled substance, conspiracy and child endangerment charges.

At the display of the CEW, the subject turned around and tried to walk away. As he was trying to walk away, the subject tripped and fell. While on the ground, the deputies and officers were able to take him into custody.
