Offense(s): PC 647(f) (Drunk in Public) and PC 148(a)(1) (Resisting Arrest).

Summary of Incident: On 1/1/2022, deputies were dispatched to a report of a shirtless, male subject crouched in the roadway and yelling profanities. Deputies contacted the subject and found he was not dressed appropriately for the cold weather, was speaking incoherently, had slurred speech, and smelled of alcohol. When deputies told him to stop, he began running in the busy roadway. Deputies followed the subject while attempting to negotiate with the subject and while waiting for additional deputies to respond. As deputies were attempting to de-escalate the situation, the subject would approach every oncoming vehicle and yell at the driver. Due to his uncooperative behavior and the safety threat his behavior posed, a deputy drew his department issued CEW, activated it and pointed it at the subject and he gave the subject commands in an attempt to gain his compliance. The subject ignored the deputies' commands and continued to evade as deputies followed. Ultimately, additional deputies arrived, and they were able to place the subject in handcuffs and take him into custody. The subject was arrested for PC 647(f) (Drunk in Public) and PC 148(a)(1) (Resisting Arrest).

Offense(s): 22350 CVC, 12500(A) CVC, 148(A)(1) PC, 11378 HS, 11379 HS, 11359 HS, 11360 HS

Summary of Incident: On 1/6/2022, a Sergeant conducted a traffic enforcement stop on a vehicle for speeding. The Sergeant determined the driver to also be in violation of 12500(a) CVC

(Expired Driver's License) and found the sole passenger of the vehicle did not have a valid driver's license either. Due to the fact there was not a licensed driver in the vehicle, and the fact the vehicle was stopped on the shoulder of the freeway and not in a legal parking space, the Sergeant determined the vehicle needed to be towed for storage per 22651(P) CVC. While the Sergeant was completing the citation, a Marin County Sheriff's Office Detective and her K9 conducted an external search of the vehicle for the odor of narcotics and the K9 alerted to the presence of narcotics odor emitting from the vehicle. The sergeant issued the citation to the driver and the driver signed the citation. Upon being advised the vehicle would be towed, the driver refused to exit the vehicle and locked the doors to prevent the deputies from gaining access to the vehicle. The sergeant physically prevented the window from begin rolled up and gained control of the driver's arm. The driver continued to refuse to comply with commands to exit the vehicle. The sergeant drew his department issued CEW, activated it and pointed it at the driver while continuing to give him commands to exit the vehicle. An additional deputy arrived and drew her department issued CEW and pointed it at the subject. The sergeant holstered his CEW and with the help of other deputies, was able to gain control of the driver's arms and placed him in handcuffs and into custody. The driver was ultimately cited for two vehicle code violations and arrested for PC 148(a)(1) (Resisting Arrest) in addition to the following drug related offenses: 11378 HS, 11379 HS, 11359 HS, 11360 HS.

Offense(s): 245(A)(2) PC- Assault with a Deadly Weapon, 273.6 PC- Violation of a Domestic Violence Restraining Order, and 24610 PC- Possession of an Undetectable Firearm

Summary of Incident: On 2/1/2022, deputies were dispatched to residence for a report that a subject brandished a firearm at his roommate and the subject was locked in a bedroom with his girlfriend and the gun. Deputies arrived on scene and interviewed the victim who reported the subject appeared to be under the influence of drugs and was acting very aggressive. The roommate had confronted the suspect out of concern for another resident in the apartment who was disabled. The suspect briefly left and returned to the victim with a firearm and pointed the firearm at the victim. The victim pushed the firearm away, exited the apartment and called the Sheriff's Office for help. Upon arrival, deputies instructed the suspect to exit the residence calmly while keeping his hands visible. Due to the nature of the call, reported demeanor of the suspect and the report of involved firearms, one deputy drew his department issued firearm and pointed it at the suspect while another deputy drew his department issued CEW, activated it and pointed it at the suspect. The suspect complied with the command to exit the residence, was placed into handcuffs, and taken into custody. Following an interview and deputies locating an un-serialized firearm, the suspect was arrested for 245(A)(2) PC (Assault with a Deadly

Weapon), 273.6 PC (Violation of a Domestic Violence Restraining Order), and 24610 PC (Possession of an Undetectable Firearm).

Offense(s): 273.5 PC (Domestic Violence) and 236 PC (False Imprisonment)

Summary of Incident: On 2/4/2022, deputies were dispatched to a meet with a victim who reported her boyfriend pushed her and placed his hands around her neck during a disagreement at their residence. The victim also reported she attempted to leave the residence, but the suspect prevented her from doing so by blocking the doorway. The suspect grabbed the victim on the back of her head by her hair and pushed her head down while holding his other hand in a fist in the air. The suspect also pushed her making contact with her upper body. The victim was able to escape and leave their residence. Upon further investigation, the deputies determined the suspect caused visible injury to the victim and determined the suspect to be in violation of 273.5 PC (Domestic Violence) and 236 PC (False Imprisonment). Deputies later located the suspect in his vehicle and conducted a High-Risk Traffic Stop. Due to the serious nature of the crime, a Sergeant removed his department issued CEW, activated it and pointed it at the suspect in his vehicle as a less lethal force option while other deputies gave the suspect commands to exit his vehicle. The suspect complied, was placed in handcuffs and arrested for the above listed charges.

Offense(s): 496 PC (Possession of Stolen Property), 459 PC (Burglary), and 602 PC (Trespassing)

Summary of Incident: On 2/17/2022, deputies responded to a hotel for a report of a female who had burglarized a hotel room and stolen items. Deputies obtained video surveillance footage of the suspect. On 2/18/2022, deputies responded to the same hotel for an unwanted subject on the property. The reporting party was an employee who stated the unwanted subject matched the description of the burglary suspect from the day prior. Upon arrival the deputies learned the suspect was inside a hotel room. Deputies created a perimeter of the entry and access points of the room and gave the suspect commands to exit. Due to the serious nature of the crime two

deputies drew their department issued CEWs, activated them and pointed them at the suspect as she exited the room. The suspect complied with the deputies' commands and was ultimately taken into custody. The suspect was arrested and booked into the Marin County Jail on the charges of 496 PC (Possession of Stolen Property), 459 PC (Burglary), and 602 PC (Trespassing).

Offense(s): Suspected Burglary

Summary of Incident: On 2/26/2022 at approximately 2335 hours, deputies were dispatched to a residence for a report of a burglary in progress. The reporting party stated she saw a male subject wearing dark colored clothing and a hooded sweatshirt attempting to climb up a ladder onto the roof of the residence. The first deputy who arrived located a possible suspect in front of the residence who matched the description provided. As the deputy contacted the first subject, a second subject approached. The deputy gave the subjects commands to show their hands to which both subjects began arguing with the deputy. Due to the nature of the suspected crime of burglary, the initial deputy being alone with two subjects and unknown weapons, the deputy pointed his department issued firearm at the subjects and gave them commands to lay on the ground until an additional deputy arrived. When additional deputies arrived, a deputy drew his department issued CEW, activated it and pointed it at the subject. The subjects complied with commands with the display of the weapons. Ultimately after further investigation, the deputies were able to determine and confirm that the subjects were residents of the house and the reporting party had been mistaken in their observations. Deputies apologized to the residents and released both subjects.

Offense(s): 211 PC (Robbery), 11550 HS (Under the Influence of a Controlled Substance), and 148 PC (Resisting Arrest), 1203.2 PC (Probation Violation)

Summary of Incident: On 3/9/2022, deputies responded to a report of a subject who forced himself into the passenger seat of a vehicle. Upon arrival, deputies learned the victim had

returned to his vehicle after a hike and a subject approached him and asked for assistance. The victim observed the suspect jumping out in front of traffic and stated the suspect's behavior made him uncomfortable. As the victim was attempting to leave, the suspect forced his way through the open passenger window into the passenger seat of the vehicle. Fearing he was about to be attacked, the victim exited his vehicle and retreated to a parking lot. While the suspect was in the victim car, he made statements to the victim that he was going to steal his car. When the victim returned to his vehicle after he could no longer hear the suspect in the area, the victim found his backpack had been stolen. Deputies ultimately determined the suspect to be in violation of robbery. Deputies searched the surrounding area for the subject.

Simultaneously, another local law enforcement agency contacted a subject matching the description approximately a mile away. The suspect would not cooperate with the officer and evaded the officer by hiding in bushes and behind trees. Deputies located the suspect on a hiking trail in area and were able to create a perimeter around him. A K9 and handler were requested from San Rafael Police Department to assist. While maintaining a position near the suspect, the suspect yelled he would shoot at deputies if he had a gun. Because the suspect was demonstrating, by words, an intention to be violent and physically resist, and because the suspect appeared to present the potential to harm deputies, a deputy unholstered his department issued CEW, activated it, and pointed it at the suspect. The deputies gave the suspect commands to comply, but he refused. The San Rafael Police Officer arrived with the Police K9. The San Rafael Police Officer gave the suspect additional commands to comply, but the suspect continued to yell profanities, challenged the deputies and officers and refused to comply. The K9 was ultimately used to apprehend the suspect and the suspect was placed in handcuffs. Despite being handcuffed, the suspect continued to physically resist the deputies and was placed in the WRAP, a further restraint device. The suspect was removed from the WRAP to be treated by medical personnel for his injuries sustained by the K9 bite. The suspect was ultimately arrested for 211 PC (Robbery), 11550 HS (Under the Influence of a Controlled Substance), and 148 PC (Resisting Arrest), 1203.2 PC (Probation Violation).
