ALERTMARIN is made available to the County of Marin residents and businesses as a supplement to, and not a replacement for, existing public safety warning and information notification systems such as television and radio. Your use of and agreement to receive notifications from ALERTMARIN does not create any duty on the part of the Marin County Sheriff's Office and the Marin County Sheriff's Office is not responsible for any action you may take as a result of a notification you receive through ALERTMARIN.

IF YOU BELIEVE YOU ARE IN DANGER, YOU SHOULD NOT WAIT FOR OR RELY EXCLUSIVELY ON A NOTIFICATION FOR EMERGENCY DIRECTIVES, BUT IMMEDIATELY TAKE ALL NECESSARY PRECAUTIONS. IF YOU ARE DIRECTED TO TAKE ACTION BY EMERGENCY PERSONNEL, YOU SHOULD FOLLOW THEIR DIRECTIONS IMMEDIATELY.

The Marin County Sheriff's Office, its officers, employees, agents and assigns make no warranty, express or implied, and assume no legal liability or responsibility for the accuracy, completeness or usefulness of any information provided by ALERTMARIN. The Marin County Sheriff's Office, its officers, employees, agents and assigns will not be liable for any damage or injury caused by the use of ALERTMARIN. ALERTMARIN may-be temporarily unavailable from time to time due to maintenance or malfunction of computer equipment.

Minors are expressly forbidden to use ALERTMARIN. Messages will be sent based on the address you provide to the phone numbers and email addresses you provide. **YOU MAY NOT REGISTER ANY PHONE NUMBERS OR EMAIL ADDRESSES THAT DO NOT BELONG TO YOU. YOU ARE SOLELY RESPONSIBLE FOR MAINTAINING THE ACCURACY OF THE INFORMATION YOU PROVIDE.** The Marin County Sheriff's Office may remove any contact information or account it believes, in its sole opinion, to be fraudulent or otherwise inappropriate.
