Below is the statistical report listing complaints received from July 1, 2025, through September 30, 2025. I've asked my staff to include a brief synopsis of each complaint received to provide you and your colleagues with some additional detail and insight.

- 1. A complaint was filed that a member displayed a lack of professionalism during an interaction. The reporting party included only an email address and did not reply to multiple follow-up messages sent to determine the merits of the claim and to provide enough information to identify the incident.
- 2. A complaint was submitted by someone who was detained for reports of looking into mailboxes. The complainant was unhappy with the initial caller and the deputy response. An investigation into the incident showed lawful and proper conduct by the deputy
- A driver reported deputies did not identify themselves by name and badge number and also requested identifying information from vehicle passengers. Attempts to contact the complainant have gone unanswered and the investigation remains open.

 An individual completed a complaint form relating to a Use of Force incident that occurred in 2021. The incident was investigated, and initially determined excessive force was not used in overcoming the resistance in the incident. The investigation is ongoing.

- A complainant opined there was a pattern over time of MCSO deputies contacting him inappropriately. In reviewing the incidents, one was a consensual contact, and the other was a traffic stop for an undisputed equipment violation. No evidence was developed that the interactions unfairly targeted this individual and the incidents were separated by several months.
- 2. Reports of possible violations of law by a department member were asserted. Documentation from the investigating agency was reviewed and no evidence of violations was identified. The incidents were not forwarded for criminal complaint, and no enforcement action was taken or recommended by the investigating agency.
