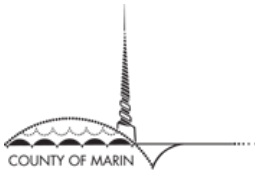

## How to provide comment on agenda items:

- **Before the meeting:** Email your comments to [oem@marincounty.org](mailto:oem@marincounty.org). Please email your comments no later than 3:30 P.M. the Wednesday before the Thursday Council meeting to facilitate timely distribution to Council members. Please include the agenda item number you are addressing and your name and address. Your comments will be forwarded to the Disaster Council and will be placed into the public record.
- **During the meeting (only):** During the meeting when it is time for public expression, use the “Raise Hand” button or press \*9 if you would like to make a comment (up to a time limit set by the Meeting Chair) when the specific agenda item is considered by the Board. Your comments will also become part of the public record.
- **Other information for public comment:**
  - General comments on items *not on the agenda* can be shared during the Public Comments section.
  - Comments specific to a **particular agenda item** must be expressed while the Council is considering that agenda item. Toward the end of the Council meeting and staff discussion, the Council Chair will ask for public comment.
  - If you miss the public comment period, please email your comment to [oem@marincounty.org](mailto:oem@marincounty.org) and you will receive an appropriate response.
