National Incident Management System (NIMS) Implementation Strategy for the Marin Operational Area

Background

Beginning in FY 2007, all federal preparedness funding will be conditioned upon full compliance with the NIMS. This Strategy distills the currently available state and federal implementation guidance. Marin Sheriff's OES will take the lead role in developing NIMS implementation information and resources. However, each jurisdiction and agency is responsible for conducting the necessary training and administrative actions. The following schedule provides a framework for completing the necessary action items. It may be adapted for other jurisdictions as well. Additional references and guidance documents are also listed below.
