Offense: 241(C) PC (Battery on a Peace Officer), 148 PC (Resisting/Obstructing Arrest), 11364 H&S (Possession of Illegal Paraphernalia)

Summary of Incident:

On 4/2/2020, deputies were dispatched to a subject who was yelling at people and panhandling in the roadway. Upon arrival, deputies contacted the subject and advised him to stay out of the roadway. The subject refused to move and refused to identify himself. When the deputies went to place the subject under arrest for 148 PC, the subject became uncooperative and grabbed ahold of one of the deputies. One deputy drew his CEW, turned it on and pointed it at the subject. The deputy gave the subject directions to place his hand behind his back. The subject did not comply, took a combative stance clenching his fists and attempted to grab ahold of a deputy again. The deputy fired the CEW at the subject hitting him in the abdomen. The subject was not affected by the CEW and became more aggressive towards the deputies. A second deputy fired his CEW hitting the subject in the abdomen. The subject paused briefly then pulled the wires of the CEW from his body. The deputies continued to struggle with the subject until additional officers arrived on scene and the subject was taken into custody.

Offense: 245(a)(1) PC (Assault with a Deadly Weapon), 243(e)(1) PC (Domestic Violence Battery), and 236 PC (False Imprisonment)

Summary of Incident:

On 4/4/2020, deputies were dispatched to a domestic dispute in which a girlfriend had threatened her boyfriend with a knife and the boyfriend deployed a Taser device which struck the female. Deputies arrived and the suspect refused to exit the residence. Deputies entered the residence and contacted the suspect. Due to the weapons involved in the domestic assault, one deputy pointed his firearm at the suspect and the other deputy drew his CEW, turned it on and pointed it at the suspect. At the display of the weapons, the suspect complied with the deputies' commands and was taken into custody.

Summary of Incident:

On 5/18/2020, deputies were dispatched to a subject who was reported to be trespassing, acting erratically and yelling at the property owner. Deputies located the subject. During their investigation, deputies determined the subject was a danger to himself due to mental illness and needed to be taken to the hospital for a mental health evaluation. As the deputies attempted to detain the subject, he pulled away from them and ran into a large bush. The subject then held a jagged piece of wood as lifted his leg indicating the intention to kick the deputies. A deputy drew her CEW, activated it and pointed it at the subject. With the display of the CEW, the subject agreed to put the piece of wood down and was taken into custody.

Summary of Incident:

On 5/22/2020, deputies were dispatched to a report of an assault in which a woman had walked up to the victim, claimed she was God and he was the devil and then punched the victim in the face. Deputies located the subject and attempted to place her into custody to be taken for a mental health evaluation at the hospital. The subject refused to comply with the deputies' commands, made incoherent statements to the deputy and started to leave. Concerned for her mental well-being and fearing she would assault someone else, the sergeant drew his CEW, turned it on and pointed it at the subject. At the display of the weapon, the subject complied and was taken into custody and taken to the hospital for a mental health evaluation.
