# <u>TYPE OF DEPLOYMENT:</u> DREW TASER, ACTIVATED, AIMED

On 1/8/2025, deputies were dispatched to multiple reports of a female suspect throwing rocks, yelling, running in the roadway, jumping in front of cars and throwing bicycle parts in the roadway. A deputy arrived on scene and attempted to speak to the suspect; however, the suspect was agitated, pacing and yelling. The deputy attempted to engage in conversation with the suspect but the suspect made incoherent statements, did not follow orders and jeopardized her own safety and the safety of nearby drivers by acting erratically in the roadway. The deputy established the need to detain the suspect in handcuffs out of concern for her safety.

The suspect resisted the deputy's attempt to place her in handcuffs by pulling away from the deputy and walking away. The suspect attempted to hit the deputy multiple times with her fist and but did not make contact. The suspect kicked the deputy in the shin twice. The suspect then ran towards a nearby pile of her belongings, picked up an umbrella and raised it in a threatening manner. The deputy drew her CEW, turned it on and pointed it at the suspect.

When another deputy arrived, the suspect dropped the umbrella and ran towards the second deputy. The deputy was able to put the suspect on the ground and place her in handcuffs. She was then arrested for charges of 69 PC, 243 (B) PC, 417.8 PC.

# **Offense(s):** Ramey Warrant – 422 PC, 594(B)(1) PC **Summary of Incident:**

On 2/6/2025, the Marin County Sheriff's Office Special Response Team (SRT) was activated to affect the arrest of an individual with a Ramey Warrant for the charges of 422 PC and 594(b)(1) PC. Due to the subject's potential threat to the community, the team assembled and constructed a thorough operational order which included the Crisis Negotiation Team and the sUAS Team, and tactical dispatchers.

The team surrounded the subject's residence and conducted announcements instructing the subject to exit his residence. The subject complied with the orders. As the subject exited the residence, a deputy pointed his department issued firearm at the subject. A second deputy had his department issued CEW drawn and pointed in a low-ready position. The subject was taken into custody without incident.

#### DREW TASER, ACTIVATED, WARNING ARC DISPLAYED

#### Summary of Incident:

On 2/9/2025, a deputy observed a subject riding a children's bicycle in the bike lane against traffic in violation of 21650(a) CVC. The deputy conducted a bicycle stop on the suspect. The suspect threw his bicycle down and began walking away from the deputy despite being told to stop. The suspect then became agitated, made nonsensical statements, refused to comply with basic instructions to remove his hands from his pockets and sit down. The suspect then began walking away from the deputy again towards nearby train tracks. The deputy drew his department issued CEW, activated it and held it at his side, pointing it at the ground. The deputy displayed the warning arc in an attempt to de-escalate the situation. At this time, additional deputies arrived on scene and the deputies were able to gain control of the subject arms and place him in handcuffs.

#### Summary of Incident:

On 2/12/2025, deputies responded to a report of an in-progress assault with a deadly weapon. The reporting party stated she was being attacked by her grandmother with a knife and her grandmother had stabbed her in the hand. The dispatchers receiving the call could hear a verbal argument in the background of the call.

A deputy arrived on scene and contacted the suspect in front of the building as she was holding two knives. The deputy drew her department issued CEW, activated it and pointed it at the ground. The deputy commanded the suspect to drop the knives to which the suspect complied. The deputy then placed the subject in handcuffs. At the conclusion of the initial investigation, the suspect was arrested for 245 PC and 236 PC.
