Offense(s): 244 PC, 594(b)(1) PC, 166(c)(1)(a) PC, and an outstanding Marin County warrant

**Summary of Incident:** 

On 4/11/2025, deputies were dispatched to a residence for a welfare check and an assault. The victim and reporting partying stated the suspect, her son, threw bleach at her hitting her in the upper chest area and broke the front window of her residence. The suspect left the residence prior to the deputies' arrival. Through further investigation, deputies determined the suspect to be in violation of 594(b)(1) PC, 244 PC, 166(c)(1)(a) PC and had an outstanding Marin County Warrant for battery. The victim advised deputies the suspect was suffering from a mental health episode. Deputies attempted to call the suspect out of his bedroom, but he refused. Because the suspect was locked alone in his room, deputies exited the residence, requested Marin County Mobile Crisis Unit respond and advised the victim to leave the residence.

Approximately an hour later, the victim called again stating the suspect was breaking additional windows. Deputies attempted verbal contact with the suspect through the locked bedroom door and broken window. Marin County Mobile Crisis Unit Staff attempted to speak with the suspect for almost an hour but did not receive a response. The Marin County UAV team responded to obtain a visual of the suspect from the third story window, but no response was received.

Deputies ultimately gained a visual of the suspect through a partially open bedroom door and attempted further communication, but the suspect did not respond and remained hidden under a blanket. Ultimately, deputies retreated from the residence again.

The following day, deputies and Marin County Mobile Crisis Unit staff made additional attempts to communicate with the suspect at his residence but were unsuccessful. He was seen moving under his sheets in his bedroom but would not comply with commands.

Later in the evening the deputies attempted contact again where the suspect had created a barricade in his room with a couch. Deputies formulated a plan, ultimately entering the room and physically detained the suspect. While contacting the suspect, one deputy drew her department issued CEW, and pointed it at the suspect. Additional deputies were able to then detain the suspect without further incident. The suspect was arrested for 594(b)(1) PC, 244 PC, 166(c)(1)(a) PC and had an outstanding Marin County Warrant for battery.

**Summary of Incident:** 

On 5/7/2025, deputies were dispatched to a report of an unknown male who trying to enter a residence. The victim observed the male rummaging in an outdoor storage cabinet underneath the house in the backyard. Deputies located the subject nearby. Due to the subject being suspected of burglary, a deputy drew her CEW, pointed it at the subject while deputies gave the suspect commands. The suspect complied with the commands and was taken into custody. The subject was ultimately arrested for prowling, attempted burglary and an outstanding felony warrant.
