

Small Unmanned Aerial Systems (sUAS) Team Second Quarter Statistics, 2025

04/02/2025 - Mission Type: Assist the San Rafael Police Department with the search for burglary suspect(s) who ran after a pursuit

Case: SO25-899 Offense: 459PC

The sUAS team was requested to assist the San Rafael Police Department with the search for a burglary suspect(s) who fled from the Santa Rosa Police Department and California Highway Patrol, ultimately crashing in the area of Lincoln Ave and Hammondale Ct, in San Rafael. An aerial search of the backyards and a steep hillside where the suspect(s) were believed to last be seen. The sUAS team flew one flight lasting approximately eight minutes. The suspect(s) were not located.

04/08/2025 - Mission Type: Assist the United States Marshal Service and San Rafael Police Department with a search for felony warrant suspect who fled on foot.

Case: SO25-972

Offense: Felony Warrant

The sUAS Team was requested to assist the United States Marshal Service and the San Rafael Police Department with a search for a felony warrant subject that fled on foot during a warrant attempt at 11 Corte Saratoga in San Rafael. The sUAS team was called out on two separate occasions in an attempt to locate the suspect. Five flights for a total of eighty minutes of flight time were conducted in the area focusing on the backyards and opens space adjacent to Montevideo Way. The suspect was not located.

04/09/2025 - Mission Type: Assist the Novato Police Department with the search for multiple suspects involved in a 245 PC.

Case: SO25-986 Offense: 245PC

The sUAS Team was requested to assist the Novato Police Department with the search for multiple suspects involved in a 245 PC. Two flights were conducted in the area of Main Gate Rd and Nave Dr in Novato prior to being relieved by California Highway Patrol air support. Two flights lasting approximately 20 minutes were completed in the area. The suspect/s were not located by the Marin County Sheriff's sUAS Team or California Highway Patrol air support.

04/09/2025 – Mission Type: Assist Central Marin Police Authority with the search for a carjacking suspect.

Case: SO25-973 Offense: 215 PC

The sUAS Team was requested to assist the Central Marin Police Authority with the search for an outstanding carjacking suspect in the area of 927 E Blithedale Ave in Valley. Two flights were flown in the area for a total flight time of approximately forty minutes. The suspect was not located.

04/17/2025 – Mission Type: Assist the National Park Police and Marin County Search and Rescue with the search for a missing person.

Offense: Missing Person

The sUAS Team was requested to assist the National Park Police and Marin County Search and Rescue Team with the search for a missing person. The search area was the Battery Rathbone Parking lot off Conzelman Road in the Marin Headlands, CA and consisted of steep terrain along the coastline. sUAS pilots conducted four flights in the area for a total flight time of approximately seventy six minutes. The missing person was not located.

04/18/2025 - Mission Type: Assist the Marin County Sheriff's Office Patrol Division with the search for robbery suspect.

Case: SO25-1080 Offense: 211 PC

The sUAS Team was requested to assist the Marin County Sheriff's Office Patrol Division with the search for a robbery suspect in the area of 115 Shoreline Highway in Mill Valley. The search area identified was of steep and inaccessible terrain where the suspect may have fled. sUAS pilots conducted one flights in the area for a total flight time of approximately eleven minutes. The suspect was not located.

04/26/2025 - Mission Type: Assist the Mill Valley Police Department with a planned evacuation drill.

Case: SO25-1161 Offense: N/A

The sUAS Team was requested to assist the Mill Valley Police Department with a planned evacuation drill. During the event, the sUAS team provided an aerial view of the vehicles travelling through the evacuation route in order to identify bottle necks in the route. The sUAS conducted seven flights for a total flight time of approximately 109 minutes.

04/29/2025 - Mission Type: Assist the San Rafael Police Department with the search for a 647.6 PC suspect.

The sUAS Team was requested again to assist the National Park Police and Marin County Search and Rescue Team with the search for a missing person. The search area was the Battery Rathbone Parking lot off Conzelman Road in the Marin Headlands, CA and consisted of steep terrain along the coastline. sUAS pilots conducted eleven flights in the area for a total flight time of approximately 131 minutes. The missing person was not located.

06/10/2025 – Mission Type: Assist the Novato Police Department with the search suspect/s involved in a vehicle pursuit and foot bail.

Case: SO25-1603 Offense: 459 PC

The sUAS Team was requested again to assist the Novato Police Department with the search for suspect(s) involved in a 459 PC in Sonoma County and subsequent vehicle pursuit and foot bail following a crash in the area of Alameda Del Prado, Alameda De La Loma and Southbound 101. The sUAS Team completed a search of the area consisting of one flight lasting approximately 20 minutes. The suspect(s) were not located.
